Detail description of Project

In July 2011, CEEFOR d.o.o. was awarded a GGF project in Serbia - the Renewable Energies and Energy Efficiency ("RE-EE") Facility, to finance public and private RE/EE projects through a credit line established with Čačanska Bank AD as a partner bank in Serbia.

GGF is supporting Čačanska Bank in Serbia in the expansion of its energy (EE/RE) loan portfolio. The aim of the participating bank is to use the funds provided by GGF for loans to households and MSMEs. Čačanska Bank is financing standard as well as non-standard EE measures. CEEFOR is engaged to verify the energy savings and CO2 emission reductions resulting from both types of measures. While standard measures are covered by a monitoring & reporting tool – which is being implemented by a third party independently of this project, non-standard measures require individual energy audits (e-audits) developed by CEEFOR.

Serbia has a large potential for renewable energy and energy efficiency. CEEFOR due diligence of presented projects indicated a lack of awareness of energy efficiency and management. Despite the economic crisis in Serbia, CEEFOR has performed already 25 verification EE/RE audits and 1 holistic energy audit. These projects requested total financing loan from Čačanska bank in the amount of EUR 2.876.465,00, and total investment of EUR 4.937.247,00 which led to 19.938.208 kg CO2 emission savings.
